Terms and Conditions

- 1. All bookings must be made on the East Rand Crafters Market forms and will not be accepted unless they are correctly completed, signed and with the correct booking fees. Signing the official booking form acknowledges full acceptance of these Terms & Conditions.
- 2. East Rand Crafters Market reserves the right to decline any Exhibitor application without giving reason. For the guidance of applicants:
 - a. It is our policy to decline an application from any applicant whose work is not considered to be of an acceptable standard or conflicts with the Terms & Conditions
 - b. Except in extreme circumstances we will not accept more than 3 applications of the same craft for any medium size market and 4 for a larger size market.
- 3. Bookings will only be secure when East Rand Crafters Market has received and acknowledged the booking form paperwork and payment.
- 4. In the event of a cancellation by the Exhibitor we reserve the right to retain any deposit or booking fees made. As a guide
 - a. a cancellation will forfeit any monies paid
 - b. deposit is non-refundable
- 5. Stand space is let to the exhibitor stated when making the booking and must not be sub-let to any other party.
- 6. All Exhibitors must be set up by the recommended setup time on the Day of the market and cleared away by the recommended time, however no stall may be cleared before 16.00 without permission of East Rand Crafters Market. If no times are mentioned, the following will come into effect:

a. Setup time: 7 AMb. Clearance time: 5 PM

- 7. Exhibitors must ensure that none of their display equipment extends beyond the space they have booked, this includes any rails, stands or additional equipment they may bring in addition to the tables provided.
- 8. Exhibitors must maintain an adequate shared access with their neighbours.
- 9. All tables must be suitably covered to ground level.
- 10. The site offered is "pitch only" unless otherwise specified. The event organisers will not supply tables, chairs, water or any other equipment unless available and booked and paid for.
- 11. The only goods permitted for sale will be those stated on the Booking / Registration Form. East Rand Crafters Market reserves the right to ask for the removal of any items not so declared
- 12. East Rand Crafters Market is not responsible for Exhibitors property whilst attending the market.

- 13. Exhibitors are responsible for any and all damage or injury to persons or property occasioned by any of their exhibits, any act or omission by them or their servants, agent or contractors. Exhibitors shall indemnify and hold harmless East Rand Crafters Market in respect of all liabilities, proceedings, damages, cost demands and expenses brought or made against or incurred by East Rand Crafters Market, in relation to or arising from any acts or omissions of the Exhibitor. Exhibitors are responsible for arranging their own Public Liability Insurance and Employers Liability Insurance.
- 14. In the event of the cancellation, abandonment, limitation or postponement of any market organised by East Rand Crafters Market, including interruption or cessation of power supply, there will be no claim against East Rand Crafters Market. East Rand Crafters Market cannot be held responsible for loss of earnings as a result of any of these circumstances nor any other action by any third party beyond their control.
- 15. East Rand Crafters Market is not responsible for the theft or any damage to the participants'
- 16. Exhibitors must comply with all requirements of The Local Environmental Health Authority, The Local Authority, The Police and the Fire Service.
- 17. The Exhibitor must predominantly make all items offered for sale.
- 18. The participant has to follow up the Health and Safety regulations, discipline, keep the market site and his / her working space clean at all times.
- 19. Exhibitors must remove from the event location all rubbish, wrapping and waste at the end of the market.
